A matt white, high density polyethylene film with a smooth, absorbent ink-receptive coating.

Basis Weight 80 g/m $^2$  ISO 536 Caliper 105  $\mu$ m ISO 534

### Adhesive

A general purpose permanent, rubber based adhesive.

#### Liner

Liner rBG40 BROWN, a siliconized supercalendered glassine paper with 15% recycled (PCR) content. Being produced with recycled material, there is a possible higher incidence of impurities, visible fibers, and slight variation in tone.

The liner is made from FSC® certified paper (FSC Mix Credit, chain-of-custody number: CU-COC-807907, Licence Code: FSC-C004451).

### Adhesive Performance

The adhesive features excellent tack and adhesion on a wide variety of substrates, including apolar, slightly rough and curved substrates. Particularly good performance at lower temperatures, e.g. labeling of chilled products.

## Applications and Use

Product gives very good performance in thermal transfer printing as well as dot matrix and conventional pre-printing techniques. The topcoating has compatibility with a wide range of wax, wax/resin and resin based, thermal transfer ribbons and is capable of producing high resolution barcode prints. The base film has good rigidity for larger label handling. Applications include medium life durable tracking labels in outdoor environments eg. chemical drum labels, or stretch and shrink wrapped pallet labels where recycling may be required.

## Conversion and Printing

The absorbent top-coat provides a 'paper like' surface for conventional preprinting. Due to the extensible nature of the face care should be taken with die specification. Sharp dies are essential. Material shows very good register stability on press and flat bed conversion while rotary and magnetic dies need additional care.

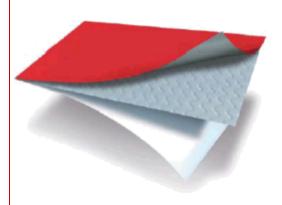
